

# Regulation of "TEDxPoznań & Samsung Flip" Contest

## I. INFORMATION ABOUT THE CONTEST

1. This document (hereinafter referred to as the "Regulation") defines the terms, conditions, and duration of the "TEDxPoznań & Samsung Flip" Contest
2. The Contest is of local character - it takes place during the TEDxPoznań conference in the Artis Hall in Poznań. It starts on 30.06.2018 at 9 a.m. and ends on 30.06.2018 at 4 p.m.
3. The organizer and sponsor of the awards in the Contest is Fundacja x.change with its registered office in Poznań, 60-474 Poznań, at 21 Czorszyńska st, office 1, entered into the Register of Entrepreneurs kept by the District Court for Poznań - Nowe Miasto and Wilda, 8th Commercial Division of the National Court Register under the number KRS 0000731895, with the tax identification number NIP 7811973763 (hereinafter "the Organizer").
4. The founder of the awards in the Competition is Samsung Electronics Polska sp. O. O., Based in Warsaw, ul. Postępu 14, 02-676 Warsaw, entered into the National Court Register - Entrepreneurs Register by the District Court for the Capital City of Warsaw, 13th Commercial Division of the National Court Register under KRS number 0000128080, share capital in the amount of PLN 52,759,500, Tax ID: 526-10- 44-039
5. The Organizer awards within the meaning of art. 919 and et seq. of the Act of law as of April 23, 1964 - the Civil Code (Journal of Laws of 1964, No. 16, item 93, as amended).
6. The Organizer informs that the Contest is not a lottery, a mutual bet, a promotional lottery or other game, the outcome of which depends in particular on the case referred to in the Act of law as of November 19, 2009 on gambling.
7. The competition takes place on the territory of the Republic of Poland with the help of two Samsung Flip devices provided by Samsung. The Contest is organized on the terms set out in the Regulation and in accordance with the generally applicable laws.
8. Only the person who meets all the following criteria (hereinafter "the Participant") may participate in the Contest:
  1. is a natural person and is not an employee or a co-worker of the Organizer, or is not a member of their families, which are considered to be: the ascendants, descendants, siblings, spouses, siblings of spouses and adopted persons,
  2. is an adult and has a full legal capacity, or is a person under the legal age with a limited legal capacity who, with the consent of the legal guardian, has an active account on Instagram or Facebook services;
  3. is a participant of the TEDxPoznań conference - Do we really have to?
  4. will read the content and accept the Regulation of the Contest;
  5. will agree to the processing of personal data for purposes related to participation in the Contest.When declaring his/hers participation in the Contest, the Participant should read the terms and conditions of participation in the Contest, specified in the Regulation. The Participant undertakes to abide by the rules contained therein as well as confirms that he/she meets all the conditions that entitle him/her to participate in the Contest.
9. Each Participant has the right to take part in the Contest. The Contest Commission, appointed by the Organizer and consisting of four of its employees, supervises the proper conduct of the Contest. The task of the Contest Commission will be to supervise the proper course of the Contest.
10. The aim of the Competition is to **draw or write an answer to the question: what do 'Do we really have to' mean to you?**
11. Participation in the Contest is voluntary.
12. Participation in the Contest and acceptance of the Regulation means the Participant's obligation to comply with the rules set out in it. By entering the Contest, the Participant confirms that he/she satisfies all the conditions of the Regulation and consents to access of the public information shared on the Participant's account.

## II. RULES OF THE CONTEST

1. Participation in the Contest requires:
  - 1. Reading the Regulation, which is equal to the acceptance of its content and consent to the processing of personal data for participation in the Contest.**
  - 2. Using Samsung's flips, provide a word / drawing response to the question 'Do we really have to'?**
  - 3. Send an answer to the email: [media@tedxpoznan.pl](mailto:media@tedxpoznan.pl). The answer should be signed with your first name, surname and email address.**
2. It is forbidden for Participants to post content within the framework of the Contest, which violates the applicable law, rules of social coexistence, good practices and rights of third parties.
3. If the Organizer discovers that the provisions of the Regulation have been violated, which includes posts with a vulgar or offensive content, non-compliant with the provisions of Polish law, promoting violence and hatred or otherwise violating the rules of social coexistence, the Organizer will be entitled to exclude the Participant from participation in the Contest with immediate effect.

4. One person can submit only one photo to the Contest. In the event that a person submits two or more photos to the Contest, only the first photo will be considered. The sequence of posted photos depends on the date of upload (post on Instagram or Facebook).

### **III. RESULTS OF THE CONTEST**

1. In the contest will be given 3 awards - vouchers - participation in Creative recording by Samsung FI! P workshops organized by Samsung.
2. Winners are determined based on meeting conditions of the Regulation, that is, answering the competition question and sending it to the e-mail address. The selection of winners will be decided by a jury composed of: 1 employee from Samsung Electronics Polska, 2 people (organizers) from TEDx Poznań, and a draftsman - Agata Jakuszko-Sobočka.
3. The winners will be informed about the awards before ending of the Conference, about 5:45 p.m. in Aula Artis
4. Participants of the Contest agree that their personal data (name, surname) will be spoken from the scene.

### **IV. AWARD IN THE CONTEST**

1. The award in the Contest is participation in Creative Recording Workshops by SamsungFI!p in Warsaw organized by Samsung.
2. There will be 3 awards.
3. One award can be granted to the 1-3 people team.
4. The Workshops take about 3 hours.
5. The award can not be exchanged for a different award or a cash equivalent. The awarded participant is not entitled to transfer his/her award to third parties.
6. The prize (vouchers) will be available to collection during the ending of the TEDxPoznań 2018 Conference. The date of the workshops will be established directly with the prize founder - Samsung.
7. Persons who will not be present at this time at TEDxPoznań conference will be informed about receiving the prize by e-mail.
8. Samsung will return travel costs for workshop participants both ways by public transport after sending purchase proofs to the email address: b.baran@samsung.com. The costs will be returned to the participants of workshops to the account number provided in the email.
9. Participants of the Competition agree for email contact from the organizer - Samsung.

### **V PERSONAL DATA PROTECTION**

1. The administrator of personal data processed as part of the Competition is the Organizer Fundacja x.change with its registered office in Poznań, 60-474 Poznań, ul. Czorszyńska 21 lok. 1 (hereinafter referred to as "the Administrator").
2. The Administrator processes personal data to the extent necessary to prepare and implement the Competition, in accordance with these Regulations, i.e. to accept the application for the Competition, determine the results of the Competition, announcement of the results of the Competition, handing in of the prize, processing of complaints.
3. The processing of personal data will be carried out according to the rules provided in (EU) 2016/679 Regulation of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to processing and transferring of personal data and repeal of Directive 95 / 46 / EC (general regulation on data protection, hereinafter referred to as "GDPR").
4. The following personal data of Participants are processed for the purposes of the Competition: name, surname, Instagram ID / Facebook ID.
5. The basis for the processing of personal data resulting from participation in the Contest is the consent of the Participant - art. 6 par. 1 point a) GDPR. To the extent that the processing of personal data results from the mandatory provisions of law (including tax regulations), the basis for data processing is art. 6 par. 1 point c) GDPR. Providing personal data is voluntary, but it is necessary to participate in the Competition.
6. Participants have the right to: obtain information about the processing of personal data, including the categories of data being processed and its possible recipients, requests for correcting incorrect data or completing incomplete data, requests for deletion or limitation of data processing - the request will be processed if the legal requirements regarding such a request are met, data transfer - by receiving data from the Administrator, a format enabling their transfer to a selected third party, submitting a complaint to the supervisory body President of the Office for Personal Data Protection - if it is found that the data is processed in violation of the law, withdrawing consent to the processing of personal data at any moment.
7. The Competition Participants' data will not be shared with external entities, except for regulations provided for by law.
8. The Organizer declares that the Competition Participants' data will not be processed in an automated manner and will not be profiled.

9. The Competition Participants' data will be kept for the period necessary to achieve the above-mentioned goals.

#### **VI COMPLAINTS**

1. Any complaints regarding the functioning of the Competition or any violation of the Regulations should be reported to the Organizer by means of a private message on TEDx Poznań Instagram website <https://www.instagram.com/tedxpoznan/> or on the Facebook page TEDxPoznań <https://www.facebook.com/tedxpoznan/> with an indication of the name, email address, as well as an indication of the exact description and reason for the complaint.
2. The participant will be notified about the Organizer's decision to the e-mail address provided.

#### **VII FINAL PROVISIONS**

1. By taking part in the Competition, participants decide to comply with its Regulations.
2. In cases not covered by the Regulations, the provisions of Polish law shall apply.
3. Participants must provide data that allow their identification.
4. The organizer does not share personal data with other entities than authorized under the applicable law.
5. These Regulations enter into force on the day of starting the Competition and are valid until its completion.
6. These Regulations are the only document defining the rules of the Competition.
7. These Regulations are subject to Polish law.
